1 DECLARATIONS OF PECUNIARY INTEREST

No declarations were made.

2 APOLOGIES FOR ABSENCE

Apologies were received from Councillors Draper, Edge and Udeh.

3 MINUTES OF THE MEETING HELD ON 28 FEBRUARY 2013

As requested at the previous meeting, Marc Dubet advised the committee that betting offices are entitled to have up to four gaming machines, which can have a maximum stake of £100 and a maximum prize of £500. Although many people are concerned about the impact of such gaming machines on vulnerable people, licenses cannot be refused because a betting office intends to have them on the premises. Marc Dubet advised the committee that the legislation states that local authorities should" aim to permit" gambling applications, and whilst evidence of crime and disorder is a reason to refuse an application, the fear of crime and disorder is not. Marc Dubet undertook to circulate any licensing case law or updates to the committee.

RESOLVED: That the minutes are agreed as an accurate record of the meeting.

THE DESIGNATION OF PARTS OF THE HIGHWAY FOR THE PURPOSE OF STREET TRADING

David Ryan introduced the report and recommended that the committee approve the designation of the two areas detailed within the report.

The committee had no issue with agreeing the designation of the area outside Ashraf Halal & Grocery Ltd in London Road, Morden.

With regard to the designation of the area outside Aubaine, 18 High Street, Wimbledon, Councillor John Bowcott noted his surprise that no local residents had

objected to this application, given that the pavement in this area is very busy, and not particularly wide. David Ryan advised that many sites on Wimbledon High Street have outdoor areas, and this application is in keeping with those.

Councillor David Simpson also noted his concerns about this application, given the amount of pedestrian traffic on the pavement in this area, especially at weekends.

Councillors asked David Ryan to provide a weekly list of street trading applications received, and asked if it could be supplied with the weekly Licensing and Planning spreadsheets sent via email. David Ryan undertook to arrange this with Marc Dubet.

David Ryan advised that the council's Insurance Section had responded to concerns raised by Councillor Chellew at the February meeting of the committee regarding the public liability insurance in place for street trading applicants. He undertook to forward this advice to all members of the committee.

RESOLVED:

- 1. To designate the street trading area outside Ashraf Halal & Grocery Ltd
- Officers to issue a temporary licence for the street trading area outside Aubaine, 18 High Street, Wimbledon until the next Licensing Committee meeting on 4 September 2013.
