A report was subsequently sent to Merton's Clinical Commissioning Group, recommending training for frontline staff, which is now being carried out.</li> <li>Healthy High Street, Mitcham – Healthwatch spoke to residents in Mitcham about possible restrictions to fast food, alcohol and betting shops in the town centre. A report has been written on this, the outcome of which is awaited.</li> <li>CAMHS – 7-17 year-olds and parents have been spoken to as part of a review of CAMHS, Child and Adolescent Mental Health Services.</li> <li>General outreach work has been done with the homeless, primary schools and local communities</li> <li>Healthwatch is also working on an Urgent Care event to get views on what works well.
