1. Special Policy Area (premises licences and club certificates)



ANNEX 1 TABLE OF MANDATORY CONDITIONS UNDER THE LICENSING ACT 2003

1. That no supply of alcohol may be made under the premises licence

(a) at a time when there is no designated premises supervisor in respect of the premises licence, or

(b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

2. That every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

3. Where one or more individuals must be at the premises to carry out a security activity, each such individual must be licensed by the Security Industry Authority by a licence granted under the Private Security Industry Act 2001 or entitled to carry out that activity by virtue of section 4 of the Private Security Industry Act 2001.

4. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises –

- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to
 - i. drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - ii. drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

5. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

6. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

(2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

(3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either - (a) a holographic mark, or

(b) an ultraviolet feature.

7. The responsible person must ensure that -

(a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures -

(i) beer or cider: ¹/₂ pint;

(ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and

(iii) still wine in a glass: 125 ml;

(b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and

(c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

8. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

9. For the purposes of the condition set out in paragraph 1—

(a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;

(b) "permitted price" is the price found by applying the formula—

 $P = D + (D \times V)$

where -

(i) P is the permitted price,

(ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and

(iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

(c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence—

(iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;

(d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

Where the permitted price given by paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

10. The admission of children to the exhibition of any film is to be restricted in accordance with any recommendation made by the relevant film classification body or relevant licensing authority.

11. No condition may be attached to the licence as to the nature of the plays which may be performed, or the manner of performing plays, under a licence that permits the performance of plays.

(3) The installed CCTV surveillance system shall be maintained and operated the whole time that the premises are open to the public, in accordance with the following:

(7) An incident book containing details of any significant public order issues is to be maintained. The incident book shall be available for inspection by Police, Local Authority and London Fire Brigade Officers at all reasonable times.

Personnel

1. The Designated Premises Supervisor Mr Sotiris Sotirou is to be replaced by a DPS approved in advance by the police licensing officer.

2. Mr Ricardo Martins is not to be employed at the premises in any capacity.

3. A personal licence holder must be present at the premises at all times it is open for licensable activities.

Hours

4. On Friday and Saturday nights the premises shall close to the public at 02:30hrs. All licensable activities, with the exception of late night refreshment, shall end by 02:00hrs. There shall be no entry or re-entry (save for smokers) after 00:30hrs.

Door supervisors and toilet attendants

5. On Sunday and Thursday nights the premises must employ at least two door supervisors from 21:00hrs (or when 40 or more customers are in the premises). The door supervisors must remain on duty for at least 30 minutes after the premises closes to the public.

6. On Monday-Wednesday the premises must employ at least one door supervisor from 21:00hrs (or when 40 or more customers are in the premises). The door supervisors must remain on duty for at least 30 minutes after the premises closes to the public.

7. On Friday and Saturday nights from 21:00hrs the premises must employ at least two door supervisors (or when 40 or more customers are in the premises). From 22:00hrs the premises must employ at least four door supervisors, at least two of whom must monitor the entry door and smoking area, at least one must monitor the 1st floor mezzanine, and at least one must monitor the ground floor. The door supervisors must remain on duty for at least 30 minutes after the premises closes to the public.

8. All door supervisors are to be provided by a reputable independent SIA company approved in advance by the police licensing officer.

9. The premises must employ dedicated toilet attendants to supervise both the male and female toilets at all times after 22:00hrs when the premises is open to the public. A written log must be kept identifying the attendant on duty at any particular time. This log is to be kept at the premises and made available to police and local authority officers upon request.

Policies: Searching, Queuing and Dispersal, Anti-Drugs, Smoking Area

10. In consultation with the police licensing officer the premises must draw up and implement a customer search policy ensuring that customers and their bags are searched prior to entry or re-entry.

11. In consultation with the police licensing officer the premises must draw up and implement a queuing and dispersal policy designed to minimise noise and disorder caused by customers in the immediate vicinity of the premises. This policy must include a procedure to regulate the number of customers within the premises at any one time (e.g. by use of a clicker).

12. In consultation with the police licensing officer the premises must draw up and implement a Smoking Policy designed to ensure that no more than 14 customers are permitted in the designated smoking area at any one time after 22:00hrs when the premises is open to the public .

13. In consultation with the police licensing officer the premises must draw up and implement an "Anti-Drug Policy". This policy must include procedures and steps to minimise the risk of illegal drugs being brought into, used, or sold at the premises. On 1st October 2018, an application was received from TASOO Ltd for a Premises Licence to be varied under Section 34 Licensing Act 2003 at the premises currently known as The Pod Bar, 105-109 The Broadway, Wimbledon, SW19 1QG.

The application can be summarised as follows:-

To change the name of the premises to CYMK.

To extend permitted hours for all currently licensed activities by 30 minutes to 2:30am, Monday to Saturday.

To remove/amend certain conditions that are no longer deemed appropriate to the proposed change in operation.

To add a condition regarding use of Body Worn Video Cameras by security staff.

The terms of the variation, if granted, will not come into effect until the substantial refurbishment has been completed and the venue is being promoted as LGBT friendly.

The Metropolitan Police Service fully supports this application, as it is our view that the Premises Licence Variation will have a positive effect on three of the four Licensing Objectives, namely:

The Prevention of Crime and Disorder The prevention of Public Nuisance Public Safety.

Currently, The Pod Bar is a small, poorly lit nightclub, playing House and Garage music to clientele in their 20s. It is in desperate need of redecoration and has been left behind by other venues in Wimbledon that have upgraded and re-branded. The occasional assault takes place inside the premises, and despite the excellent staff's best efforts, The Pod contributes to more than a fair share of Wimbledon's night time incidents of disorder and Anti Social Behaviour. Without a significant upgrade soon, the venue will deteriorate and crime/ASB will increase.

There are two more late night venues in Warder 30 own Centre vying for a similar market, Smash (opposite) and Tunnel 267, further along The Broadway. Tunnel 267 is licensed to

sell alcohol to 3am, closing at 3:30am Monday to Saturday. Smash, is also licensed to sell alcohol to 3am, close at 3:30 Friday and Saturday, to 2am (2:30am close) Monday to Thursday. Currently, when The Pod closes at 2:30am, customers often take the option of rushing to Smash or Tunnel 267 for a final half hour of drinking. This can promote reckless and excessive alcohol consumption. Extending the applicant's closing time by 30 minutes will remove the last hour rush to other venues and create a more effective staggered dispersal.

The additional half hour across licensed activities, and removal/amendment of certain restrictive conditions will allow the applicant to undertake a full refurbishment of the venue and re-open as a gay friendly venue. I have had several meetings with the applicant to discuss the proposed refurbishment in great detail and my recommendations have been fully accepted. Communication between us is excellent and I have full confidence in the licence holder's ability to operate a safe and responsible late night venue.

CYMK will be marketed as an LGBT friendly venue and the benefits of this to Wimbledon town centre are potentially huge. The risk of crime and ASB connected to the venue will most certainly plummet. Diversity within the Night Time Economy is well documented as important in reducing crime and promoting public safety.

When the PoNaNa nightclub opposite re-branded to Smash in 2017, the reduction in crime and ASB was instant. The quality of the clientele improved and change in atmosphere was immediate. The knock on effect was noticed by other venues in that area of the town centre as the quality of clientele increased. Wimbledon town centre has become safer as nicer people, less inclined to be involved in ASB or disorder, are drawn to the area. I am confident that the change from The Pod to CYMK will have the same effect.

I firmly believe that the creation of CYMK will have a positive effect on the overall profile of Wimbledon's NTE by reducing risk of crime and increasing safety. The terms of the proposed variation will not have a negative impact on any of the four licensing objectives.

I fully support this application and I recommend that the Premises Licence Variation is granted.

I write on behalf of Wimbledon E Hillside Residents' Assn (WEHRA) to share our views on the application to extend 'supply of alcohol' at this venue a further 30 minutes to 2:30 am, Monday to Saturday.

Background

Bar Sia/Pod Bar applied for a nighttime extension a few years ago, and the application was refused, such was the damage being done to Wimbledon town by the late night visitors/drinkers.

These problems persist, and the town late at night is often a battle zone, with drinkers/drugged visitors misbehaving and often requiring emergency call outs from the police and ambulances, clogging St George's ER. Then an army of street sweepers race through in the early morning hours, scurrying to clear away the disgusting waste left behind.

These challenges with licensed premises is why Wimbledon town has a CIZ. These facts are evidence the CIZ is required, and needs strict enforcement. Sirens wake up the local community trying to sleep at night; filthy footpaths, damaged trees, signposts uprooted and a hundred of bags of litter are left behind for the local community the following morning. No one person from Merton Council is removing the vomit and urine, and this remains a thorn in the side of local people who expect areas around their home - Wimbledon - a place that should be kept clean, tidy and welcoming.

Of course the damage mentioned above is not all attributable to the Pod Bar, but a later opening/selling of booze by any of the 'late late night' venues will add to these serious problems. The NHS/emergency services simply cannot be expected to manage - day in and day out - the steady stream of drunken 20/30 somethings, exhausted/drunk/on drugs/fighting from WTC.

Latest Police Data (July 2018)

We know that Wimbledon is the place young people from Merton and Croydon go to have 'a good night out'. Police crime data shows that. In July 2018 there were 27 crimes reported of anti-social behaviour in Trinity Ward (nearly one each day), and 56 drug-related crimes reported (two a day). The 'core' is the junction of Broadway and Kings Rd, where Pod Bar is located. This is a Hub in the town where problems occur. (Note there are nice family homes on Kings Road, yards from this junction, and thousands of homeowners in the South Park Gardens area that suffer daily from these on-going problems.)

Proposed New Bar

We have heard that there is a possibility the owners may change the venue to become a LGBT bar. While that is an interesting positioning, and quite a leap from the existing business the owner has offered, it doesn't really matter what the 'concept' it, it's all about the execution.

The Licensing Committee will know Wimbledon as a stable, affluent, well-educated and generous community where *all are welcome, no exceptions*. Wimbledon doesn't attract 'hate crimes' or 'gay crimes' or other such things; they haven't come to the attention of our Councillors or our community. There are many residents who are LGBT in Wimbledon. They don't need to single themselves out; this is a fluid society where we move freely. It seems peculiar that such an exclusive positioning would even be successful here, as it could encourage social segregation. In any case this proposal would be no justification for extending 'sale of alcohol' hours further into the nighttime.

Suggestions to the Premises Owner

The bar is set within the thriving Wimbledon Theatre site, yet the venue doesn't even open until 9/10 pm. See attached images. There is a great need for this venue to be refurbished and taken to a higher level of quality than at present.

In the past, area school teachers used to be known to gather there for a drink and chat after work, from 4 / 5 pm into the evening. (That business has since gone elsewhere because the venue became badly managed.) Today the bar is dark and dingy, the furniture is cheap and broken, the floor needs a proper clean etc. It is no wonder a new direction is being sought.

Perhaps the owner could look at some other ideas, opening the venue during the daytime and evening, instead of trying to eek out a niche into the later night. Go back to being a 'teachers' rest', for example. Or open a coffee shop/wine bar for pre theatre and post-theatre audiences. **Please open during the daytime**, when Wimbledon people are out and about, and able to enjoy the town's offerings. Wimbledon residents are upmarket, social and enjoy a sustainable community life. The present venue, in our view, does not sit well with the needs and wishes of the community.

Summary

In our view the applicant is splitting hairs, if they believe a 30 minute alcohol extension can improve, indeed save this business. We urge the Committee to refuse permission, and urge the applicant to consider a better quality, more a Wimbledon-appropriate concept in future.

In any case, we would urge the Committee to add a condition to the existing licence:

To sweep the front of the premises at 105-109 Broadway and the area just to the left (along wall beside theatre car park) and to the right in front of the studio theatre, to ensure their late night guests' cigarette butts, litter etc are removed, and that a disinfectant is used to remove any vomit or urine left behind in this same area, even if it is not from the Pod Bar's own customers.

A good number of other licensed venues in the town have agreed to this condition as an act of Goodwill to the local community, including SMASH, and it would be very much appreciated if the Pod Bar owner would accept such a condition as well.

Thank you for consideration of the views of the local community.







Thanks for the quick reply. My earlier correspondence did mention two of the four objectives you mention below. That is prevention of crime and disorder and prevention of a public nuisance. I did not realize we had to spell out the specifics. Thanks for clarifying this. The specifics are that currently:

- There is significant litter / rubbish that comes from late night activities in the vicinity of the bar [public nuisance, disorder]
- On many nights (especially weekends) there are incidents of extremely drunk patrons staggering down our street yelling at the top of their lungs and getting into arguments outside our house [nuisance, safety, disorder]
- Increased crime in the areas of the bars on The Broadway (demonstrated by police statistics) [crime]

With the proximity of the residential area the bar is just too close for the owner to effectively control the patron behavior, noise and litter to prevent a nuisance completely. We co-exist as best as we can for now but all of the above will worsen with extended hours. We say enough is enough.
