Meeting notes and action points

Agenda item 1: Apologies for absence - none

Agenda item 2: Declaration of pecuniary interest— no declarations of pecuniary interest.

Agenda item 4: Public consultation on Merton's Local Plan (stage 2a)

Councillors considered the report and raised points including:

- Consultation must involve councillors they have huge links across the borough and can spread the reach further
- Councillors asked questions including:
 - Consideration of timetable change with government white paper proposals
 - Queries on government changes including increasing the level at which Local Planning Authorities can ask for affordable housing contributions from 11 homes to at least 40 homes, the government White Paper consultation including the approach to the national levy, the approach to calculating the number of new homes needed; the Litchfield reports
 - o approach to assessing development viability
 - o changes to climate change policies (Send briefing note to councillors)
 - whether the proposed 50% affordable housing on private schemes would apply to Merantun Developments
 - o Planning policies on build to rent
 - o How new contributions from small sites to affordable housing could be spent.

RESOLVED:
