4 MINUTES OF THE PREVIOUS MEETING (Agenda Item 4)

RESOLVED: That the minutes of the meeting held on 10 February 2021 were agreed as an accurate record.

5 ANNUAL GOVERNANCE STATEMENT 2020/21 (Agenda Item 5)

The Treasurer presented the Annual Governance Statement which Merton is required to compile each year. As far as possible this was compiled with the solace framework and measured how the board had performed against the key principles. The report also outlined work that would be carried out during the upcoming year.

#### **RESOLVED:**

That the Annual Governance statement was noted and agreed.

#### 6 ABSTRACT OF ACCOUNTS 2020/21 (Agenda Item 6)

The Treasurer presented the report, an annual report to the board. The Treasurer gave an overview of the recommendations which were to approve the set of accounts and approve the annual audit return which required signing off. The report also included revising estimates for activity set back in February 2021 for the financial year 2021-22 and asking the board to reconsider whether to increase the possible draw down from reserves. Finally the Board were asked to agree the risk register.

It was noted that in regards to this year's activity there had been a large underspend compared to the budget. This was mainly due to delivery of the special projects programme and additional income being achieved. The cause of this additional income had been linked to the impact of Covid-19.

The Treasurer gave an overview of the debtors and creditors.

In response to questions from members, the Assistant Director Public Space advised that future pandemics would be included within the risk register and this would be reviewed for the next stage as well as looking at any future impacts on the risk register.

#### RESOLVED that the board:

- A. Received and approved the Draft Abstract of Accounts for 2020-21
- B. Approved the Annual Audit Return for 2020-21 (Appendix E)
- C. Approved the revised revenue estimates for 2021/22 in Appendix I
- D. That the Board decided not to increase the possible repayment of reserves from £800k to £1m (paragraph 2.5) in light of the outturn position
- E. Reviewed and Agreed the Risk Register as at June 2021 in Appendix J.

#### 7 CONTRACTOR REPORT (Agenda Item 7)

The Cemeteries Manager presented the report advising that the recent IT issues had not affected the efficient running of the cemetery as the majority of the work was paper based and that the server was now up and running again.

In response to questions, the Assistant Director of Public Space advised that this incident had happened nationwide across the whole infrastructure and whilst it had not happened locally it had affected local services. A risk based approach had been taken and the service had been restored.

In response to further questions, the Cemeteries Manager responded that maintenance of the graveyard did come under IdVerde, noting that when there is heavy rain soil does have to be topped up however this was part of the maintenance programme.

#### RESOLVED:

A. That the Committee reviewed the information and noted the content of the report.

#### 8 CLIENT UPDATE REPORT (Agenda Item 8)

The Assistant Director Public Space presented the report noting in particular within the 2021/22 programme the work outlined within the report on the installation of new beams to allow effective replacement of failed beams, noting this was recommended that those were supported to ensure the integrity of the site. A schedule for these works was also included within the report.

In response to questions from members, the Assistant Director Public Space assured members that officers would be writing to grave owners, would rectify at the contractor's cost to make them safe and would engage with grave owners during that time with any unsafe memorials.

The Board noted that it had been a very difficult time for the burial service in particular, praised the work of all within the service and put on record the boards thanks to all those who had worked so hard during this recent time.

#### RESOLVED:

- A. That the Committee noted the positive work undertaken by both the service provider's (idverde) cemeteries management team and the client officer team for the continued delivery of sustained services throughout the current pandemic recovery period.
- B. That the Committee noted and provided feedback on the proposed programme of works for 2021/2022.
- C. That the committee noted the separate programme of works to remedy the headstones made safe by being laid down in Section M

#### 1. **Purpose of the Report and Executive Summary**

1.1 This report presents the projected outturn for 2021/22 based on the budgetary monitoring to 31 January 2022 and revenue estimates for 2022-2023.

#### 2. **Details**

#### 2.1 **Estimates**

- 2.1.1 The Board's 2021/22 Budgetary Monitoring is attached at Appendix A (columns 1 to 5). The draft Revenue Estimates for 2022/23 are attached as Appendix A (column 6). All estimates are at outturn prices.
  - Supplementary details are contained within appendices:
    - Salaries, pension contributions Appendix B
    - Management and administration expenses Appendix C
    - Loan repayment Appendix D
    - Rental income Appendix E
    - Depreciation Appendix G
- 2.1.2 Appendix F contains the precept history of the Merton and Sutton Joint Cemetery Board.

2.1.2 Estimates have been compiled utilising the best information available at the time of despatch, where appropriate inflation of 2.5% has been added to reflect price inflation. A budget update will be provided at the June meeting of the board.

#### 2.2 Income

- 2.2.1 Prudent assumptions on the level of income generated from contractual arrangements have been made. The revised fees are attached at Appendix H, comparison of current and revised fees to neighbouring local authorities is made at Appendix H1.
- 2.2.2 Appendix E details the expected rental income in 2021/22 and 2022/23

#### 2.4 Salaries

- 2.4.1 Salaries to the Board's part time Chief Officers, i.e. Clerk, Treasurer, Registrar and Consultant Surveyor are increased annually in line with negotiated and announced Joint Negotiating Committee (JNC) awards in accordance with the Board policy, approved on 8th March 1972 (Min. 48/3/72).
- 2.4.2 The Board meeting of 24th April 1989 resolved that subject to there being no legal impediment, future salary awards for the Board's part time officers be implemented from 1 April each year so as to coincide with the Board's financial year. Allowance of 2% pay award has been built into salary estimates for 2022/23.

#### 2.5 Loan Repayments

2.5.1 Appendix D sets out the interest and principle repayments incurred from the £1.763 million loan for various works. It is assumed that the loan will be over 25 years (the anticipated life of the extension) at a rate of 3.47% (rate as at June 2013). The Appendix highlights that the board will be in year 10 of the repayment schedule in 2022/23. The repayment commitment within this schedule has been fed into the estimates in Appendix A.

#### 2.6 Special Projects

2.6.1 Good progress is being made on delivery of the special projects during 2021/22, additional detail on this will be provided as part of the Client Report.

2.6.2 The special projects budget for 2022/23 is proposed as follows:

# Risk Management Strategy

Revised February 2019

#### **Policy Statement**

MSJC's policy is to manage our risks by identifying, assessing and controlling them, with the aim of eliminating or reducing them to acceptable levels whilst being mindful that some risks will always exist and will never be eliminated.

The Board recognises its responsibility to risk management by supporting a structured, systematic and focussed approach to risk management through the approval of our risk management strategy. To optimise effectiveness the Board have adopted Merton's approach, policy, strategy and processes to dovetail with that embedded into the London Borough of Merton's operational and strategic activity.

The effective management of risk is at the core of our approach to delivering cost effective and efficient services as well as sound governance and is a continuous and evolving process, running through our strategies and service delivery arrangements. As risk is very much concerned with our objectives, the management of it will be closely linked to the creation of our strategic, service, project and partnership objectives and plans.

Our risk management process will be continuous and will support internal and external change. The risk management process will be fully integrated with the normal business management processes across the organisation.

MSJC's aims and objectives in relation to risk management are to:

- Establish and maintain a robust framework and procedures for the identification, analysis, assessment and management of risk, including reporting and recording.
- Minimise the cemetery's exposure to unacceptable levels of risk, minimise injury, damage, loss and inconvenience to staff, residents and service users.
- Integrate risk management into the day to day activities of staff and the culture of the organisation, raising awareness of the importance and need for risk management.
- Assign clear roles and responsibilities for councillors and officers responsible for risk management
- Ensure consistent application of our methodology across all of our activities, including partnerships and projects.
- Effectively manage the total cost of risk.

We will achieve this by:

- Having a clear and concise risk management strategy which underpins our approach and responsibilities to risk
- Incorporating risk management into business planning, project management and service delivery
- Monitoring and reporting risk on a regular basis to very Board meeting.

#### **Risk Management Strategy**

The process of identifying and evaluating risks is known as risk assessment. By understanding the risks we face, we are better able to actively recognise where uncertainty surrounding events or outcomes exists, and identify measures which can be taken to protect the cemetery, its staff, residents, customers and assets from these risks.

This strategy provides a structured approach to identifying emerging risks as well as assessing and managing current risks. It also incorporates a process for regularly reviewing and updating identified risks.

This strategy will be reviewed on an annual basis, and updated where required.

#### What is risk?

Risk is the threat that an event or action may adversely affect an organisation's ability to achieve its objectives and successfully execute its strategies. A risk can be a threat, obstacle, barrier, concern, problem or event that may prevent us fulfilling our objectives.

Our risk management processes also include the assessment of Issues. Issues are current problems, questions, outstanding items, tasks or a request that exists in the immediate present. There is a strong element of fact surrounding it. An issue becomes a risk when the issue cannot be addressed and could continue or get worse.

#### **Definition of Risk Management**

Organisations exist to achieve their ambitions, aims and objectives. Risk Management is the process by which organisations methodically address and identify the risks that may prevent them from achieving these ambitions, aims and objectives. The intention is to achieve sustained benefit within each of their activities, and across the portfolio of all their activities.

Ultimately, risk management is about creating a better understanding of the most important problems facing organisations.

Risk is also implicit in the decisions all organisations take; how those decisions are taken will affect how successful they are in achieving their objectives. Decision making is, in turn, an integral part of the day to day existence and is particularly significant in times of change. Risk management therefore is a key component in the management of change and helps to support effective decision making.

We endeavour to identify all risks facing the cemetery and to monitor, manage and mitigate (where possible) all those risks which are deemed to be high (scored Amber or Red).

#### The benefits of risk management

In addition to the business and service benefits of our approach, we are required to undertake risk management because it forms part of the Annual Governance Statement. We must, therefore, demonstrate that we have a systematic strategy, framework and process for managing risk.

However, the Board recognises that the benefits of risk management far outweigh the requirement to undertake the activity and such benefits include:

- Stronger ability to achieve our ambitions, aims and objectives as key risks are managed.
- Better decision making as we are more aware of risk.
- Ability to take advantage of opportunities because we understand the risks attached to them.
- Better governance and the ability to demonstrate it to our stakeholders.
- Reduction in failure, loss, damage and injury caused by risk
- Improvement in our ability to adapt to change
- Improvement in our corporate governance
- Compliance with statutory and regulatory requirements

#### Organisational awareness of risk and risk management

Ensuring that there is a strong organisational awareness of risk management will be achieved through utilisation of the procedures and processes put in place by the London Borough of Merton including training sessions, reviews, departmental meetings, briefings and staff bulletins which will take place on a regular basis. The <u>risk management intranet page</u> will be regularly reviewed and staff will be signposted to the information they need to pro-actively identify and manage risk i.e. the Risk Management Toolkit and other guidance.

#### **Risk Appetite**

The cemetery recognises that its risk appetite to achieve the corporate priorities identified within its business plan could be described in general as an "informed and cautious" approach. Where significant risk arises, we will take effective control action to reduce these risks to an acceptable level.

It is also recognised that a higher level of risk may need to be accepted, for example to support innovation in service delivery. To offset this there are areas where the cemetery will maintain a very cautious approach for example in matters of compliance with the law, and public confidence in the cemetery, supporting the overall "informed and cautious" position on risk.

#### How does risk management integrate with other policies?

Risk management links closely with Health and Safety, Business Continuity, Emergency Planning and Insurance; by ensuring close links we can enhance our resilience. Generally, a single issue or risk will fall into only one of these categories; however some may fall into two or more. As Business Continuity is a way of mitigating risk, its link with risk management is key to ensuring the continuous delivery of services which are important to the community.



#### Risk management in projects

Risk management is a key part of the ongoing management of projects and partnerships and is clearly defined in Merton's Approach to Projects (MAP).

#### Risk management in partnerships

The cemetery is likely to be involved in a range of partnerships to achieve our ambitions, aims and objectives. It is vital we assess the risks to achievement within our key partnerships, and ensure that they are monitored regularly.

#### Risk management and financial planning

Risk management is an important part of financial planning. As part of the budget setting process a robust risk assessment is completed, and then reviewed on a regular basis.

It is important that risks identified and assessed at an operational level can be escalated to managers and the Board. However, because a risk may have a great impact on an individual does not necessarily follow that it may have the same impact on the service.

#### **Financial Risk Management**

Local government has faced unprecedented financial challenges in recent years that are likely to remain well into the next decade. The harsh financial economy faced by local authorities has led Central Government and the public sector accounting body CIPFA to start to consider how best to minimise the chance of further Section 114 notices being released and providing early warnings of authorities being unable to balance their budgets.

For MSJC focus is placed on monitoring contractor information regarding income to ensure targets are met, monitoring costs to ensure operations are conducted within the income generated and an awareness of the future impact of the organisation's pension fund and its long term business model to ensure that sufficient reserves exist to maintain the cemetery when all burial space is utilised.

There is also a financial impact element to the authorities risk matrix which has been recently reviewed and simplified. Officers will continue to review activity and adopt best practice etc. where appropriate

#### **Scoring Risk**

In conjunction with this strategy, more detailed guidance will be issued to assist officers in identifying risks and issues, and the scoring, managing and reporting of those risks identified.

When determining a score for cemetery level risks, definitions of likelihood and impact of risk should be used in conjunction with the matrix below. Therefore, if the likelihood of a risk is 4, significant, (occurs or likely to occur more than 25%, and up to 50% of the time) and the impact is 3, critical, (service provision - service suspended short term) – then the risk rating will be 12 (4x3) which is amber.

#### **Defining the Likelihood of Risk**

#### Reporting and escalating risks

All risks are reviewed for reporting to each meeting of the Board. Officers and staff linked to the cemetery are expected to raise risks and issues as identified. These are then reviewed and where necessary escalated to the Board.

#### **Monitoring and Managing**

During the year, new risks will arise that have not previously been considered and there may be changes to existing risks. Therefore the risk register needs to be regularly managed, with risk owners re-assessing their risks, re-scoring them if appropriate, and providing sufficient narrative in respect of the Control Measures they have in place (i.e. the actions which they are taking to mitigate against the risk). The reviews of risk registers should be managed by exception.

The Board have adopted the London Borough of Merton's approach to risk management and as such the MSJC Risk Register is reviewed by Merton's Corporate Risk Management Group to ensure consistency of treatment throughout the Authority.

Removal of any risks from the registers must be approved by the Board. To be removed from the register risks must have remained green for two consecutive meetings of the Board. There are otherwise no rigid guidelines for dropping risks from the registers because clear parameters are not always possible. A decision is sometimes taken to keep a low-scoring risk in view on the basis that its status might change over a short period, or so those with an assurance role can be confident mitigation against a risk can be sustained

#### Roles, Responsibilities and Governance

#### **Board**

Elected councillors are responsible for governing the delivery of services to the local community. Councillors have a responsibility to understand the key risks the cemetery faces and will be made aware of how these risks are being managed through the annual business planning process. All Councillors will have a responsibility to consider the risks associated with the decisions they undertake and will be informed of these risks in the plans and reports submitted to them.

#### **Officers**

Officers are ultimately accountable in ensuring that risk management is fully embedded in the Cemetery's business planning and monitoring processes as well as having overall accountability and responsibility for leading the delivery of the cemetery's Risk Management Strategy. They will take a leading role in the risk management process, ensuring that risk management is communicated, understood and implemented by Councillors, mapages and staff.

#### Client Side/Contractor

Client Side/Contractor have a responsibility not only for the risks for which they are the risk owner, but are also accountable for those risks, within their service, which are owned / managed by others.

They are required to maintain an awareness of risk and ensure that any risks they identify are captured by the risk management process, understanding and responding to the key risks which could significantly impact on the achievement of their service and/or team objectives. Managers should encourage staff to be open about risk so that appropriate mitigation actions and control measures can be agreed.

#### **Risk Owners**

Risk owners are responsible for identifying and implementing appropriate actions which will mitigate against risks they own and reduce these risks to a level acceptable to the organisation. They are required to regularly review the effectiveness of their control measures and provide information as part of reviews to the Board.

#### **Individual Staff**

Individual employees need to have an understanding of risks and consider risk management as part of their everyday activities, identifying risks deriving from their everyday work, processes and environment. Risks which could impact on service delivery, the achievement of objectives, or their own or others' wellbeing must be identified and actively managed, with mitigating actions in place where appropriate.

#### 1. Purpose of the Report and Executive Summary

#### 2. Details

#### 2.1. Grounds Maintenance

Scheduled works continued with a focus on critical burials tasks and grounds maintenance work such as grass cutting, hedge trimming, topping up graves, and maintaining the planting and upkeep service.

Customer care remains a key focus for families and funeral directors within the team at the cemetery and the cemetery office.

#### 2.2 COVID 19 – Modification to working practices

Following government guidance, there are no restrictions to the number of mourners in the chapel or at grave side.

Hand sanitiser stations are in place at the entrance of the chapel. A Bluetooth speak is provided to the family to play music.

#### 2.3 Health and Safety Audit of Headstone Testing

The testing procedure has been agreed with LBM officers.

Section M: This section has now been completed. Failed headstones have now been reinstated on individual concrete landing stones in front of the old concrete beam, as this is no longer fit for purpose.

Section MU: This is scheduled for late February 2022 to reinstate failing memorials. The intention is that these be reinstalled back onto the concrete beam wherever possible.

Testing is being resumed as part of the Government Roadmap out of all COVID restrictions.

#### 2.6 Cemetery Boundary Improvements

idverde is in preliminary talks with Suez to improve the boundary fence between the cemetery and Suez recycling centre. It is proposed that new fencing and improved landscaping be considered.

Garth Road Boundary hedge line. Visual improvements could be undertaken to improve the appearance of the cemetery running along Garth Road and within the cemetery.

Presently this is mixture of overgrown shrubs with an assortment of poorly maintained trees. Both trees and the shrubs overhang the cemetery railings causing obstruction on the narrow pavement which also is obstructed with parked cars on the pavement. The present hedge line could be replaced with a yew hedge, this has a dense foliage for privacy for the cemetery. It would planted away from the railings and kept at a set height. Inside the cemetery a new grass verge would be created with new tree planting such as flowering cherry trees.

The estimated cost could be approx £20,000 to undertake the works. Further discussion is thus required to investigate possible funding options

#### **Recommendations:**

- A. That the Committee note the continued positive work being undertaken by both the service provider's (Idverde) cemeteries management team and client officer team for the continued delivery of excellent services throughout the pandemic recovery period.
- B. That the Committee note and feedback on the programme of works for 2021/22.
- C. For the Committee to note the next programme of works to remedy the headstones made safe by being laid down in Section MU.

#### 1 PURPOSE OF REPORT AND EXECUTIVE SUMMARY

- 1.1. The Cemeteries Service continued to experience Covid challenges during the period since the last report although the service saw the benefit of Covid19 forward planning procedures put in place by the team during 2021 and the impact that this has had on the positive movement of the capital works programme.
- 1.2. The Public Space division, Facilities Management and Idverde's proposed programme of improvement works for the 2021/2022 period continued with the below agreed sections now complete including Section M, Section F, Section X, Section BX with Section KX and Section MU still outstanding but planned to commence in February 2022.
- 1.3. The review of the Memorial Safety Testing Programme (MSTP) procedure has been agreed between LBM Officers and Idverde with Section M failed headstones having been reinstated on individual landing stones in front of the old concrete landing beam that was no longer fit for purpose. The Section MU has now been scheduled for late February and propose to reinstate failing memorials onto the concrete beam where possible.
- 1.4. Highways road surfacing contractor has commenced cemetery roadway improvements running parallel to Green Lane and other roads and footways have been inspected for future planned works.
- 1.5. Cemeteries and Boundary Improvements; Idverde are talking with Suez to improve the boundary fence between the cemetery and Suez recycling centre. It is intended that new fencing and improved landscaping be considered. Garth Road Boundary hedge line. Visual improvements could be undertaken to improve the appearance of the cemetery running along Garth

Road and within the cemetery, which will be considered in this forthcoming year's work programme.

#### 2 DETAILS

#### 2.1. Managing the Service during the Pandemic

- 2.1.1 In order to maintain services through the Government roadmap out of restrictions, the Business Continuity Plans remain in place and Idverde are ensuring suitably trained staff are available to undertake the service.
- 2.1.2 The governance of the service continues to be supported through regular monthly contract meetings and weekly burial capacity updates.
- 2.1.3 Additional resources have been made available to the Cemeteries Service to ensure that demand could and can be managed throughout any peak periods of the challenges brought by the pandemic. The service shall be returning to a normal business model in the new municipal year and with the loosening of governmental restrictions.
- 2.1.4 Following the latest government guidance, there are now no restrictions to the number of mourners in the chapel or at graveside. Hand sanitiser stations are in place at the entrance of the chapel. A Bluetooth speak is provided to the family to play music.
  - 2.2. Merton and Sutton Joint Cemetery (M&SJC) Update Programme of Works 2021/22 and Proposed Programme of Works 2022/2023
- 2.2.1 The 2021/2022 program is still on track for practical completion within the 2021/2022 financial year, progress update below and pictorial summary to follow ahead of next M&SJC board meeting.

**Section M** This section has now been completed. Failed headstones have now been reinstated on individual concrete landing stones in front of the old concrete beam, as this is no longer fit for purpose.

**Section F** Replacing old beams and an installation of the new beam is now complete.

**Section X** Work has started to replace two beams in this section.

**Section BX** New beams have now been installed in this section.

**Section KX** Requires beams which is the next general Muslim section.

**Section MU** The MU section has been inspected and price sought with works expected to commence in late February.

- 2.2.2 The working relationship between the Public Spaces Team and Facilities Management Team working with service providers idverde has strengthened during the period and the Memorial Safety Review Meetings (12<sup>th</sup> January 2022) continue to share progress updates of the ongoing memorial safety programme.




Figure 1 - Merton and Sutton Joint Cemetery (Section MaP)

- 2.2.3 Figure 1. below is a map of the sections within M&SJC. This map is included to aid with referencing the locations of the programme of works.

#### 2.3. Memorial Safety Testing Programme

- 2.3.1 Local Authorities have a duty, both to members of the public and their own workers, to make sure that cemeteries and graveyards for which they are responsible are safe. Memorials can become unstable over time and cause accidents to people.
- 2.3.2 To prevent this and reduce risk, the safety of memorials is tested at prescribed intervals by the service provider (Idverde). Memorials identified as unsafe are made safe in the interim. The make safe method applied is dependent on the nature of the risk. The process of testing memorials and mitigating any risk identified is called the Memorial Safety Testing Programme (MSTP) and the Client and Service provider Idverde meet regularly to review the Memorial Safety Programme.

The client team met with the contractor on the 12 January 2022 to review the agreed processes and refined approach to memorial failures as agreed (see M&SJC Board Meeting June 2021 (section 2.4.5)) in order to recommence the programme and progress through the year to provide assurance of site safety with memorial headstones.

- 10.4. When memorial testing is being undertaken, staff wear appropriate PPE. This includes gloves, steel toe-cap boots and high-vis jackets.
