## Licensing Sub-Committee Report

### **1. Special Policy Area (premises licences and club certificates)**

The premises are not in the special policy area on cumulative impact.

### **2. Type of hearing and powers of the sub-committee**

2.1 The sub-committee is required to determine the application by taking such of the steps set out below as it considers appropriate for the promotion of the licensing objectives.

2.2 In making their determination the sub-committee must have regard to the Licensing Act 2003, the licensing objectives, guidance issued by the Secretary of State and Merton's Licensing Policy.

2.3 New premises licence: s18

(i) To grant the licence subject to conditions

(ii) To exclude from the scope of the licence any of the licensable activities to which the application relates

(iii) To refuse to specify a person in the licence as the premises supervisor

(iv) To reject the application.

### **3. Hearing papers**

3.1 The applications, notices and representations for determination by the sub-committee are contained in the hearing bundles together with any relevant existing licence. This includes any documents which must be sent to any of the parties to the hearing under Regulation 7(2) and Schedule 3 of The Licensing Act 2003 (Hearings) Regulations 2005. This bundle has been issued to all parties to the hearing.

### **4. Legal advice to the sub-committee**

4.1 A legal officer appointed by the Assistant Director of Corporate Governance and Head of Legal Services will attend the hearing to advise the sub-committee on statutory provision and legal matters.

### **5. Licensing Officer comments**

5.1 This is an application for a new premises licence, for a premises described in the application as a fast food store with delivery service.

5.2 The applicant originally applied for the provision of late night refreshment Monday to Sunday 23:00 to 05:00 the next morning, with an additional hour on the day when British summertime commences.

5.3 The opening hours are stated in the application as 24 hours Monday to Sunday.

- 5.4 On the 25 January 2024, after consultation between the Applicant and the Metropolitan Police, we received an email stating that the applicant had agreed to amend the application. The amendment is as follows:
- Late night refreshment hours reduced – Monday to Sunday 23:00 to 02:00 the following morning.
  - Hours open to the public hours reduced - Monday to Sunday 11:00 to 00:00
  - Deliveries only, times reduced - Monday to Sunday 00:00 to 02:00.
  - Four conditions were agreed. These conditions are included in an annex to this report.
- 5.5 The application sets out steps that the Applicant will take to promote the four licensing objectives. Conditions consistent with those steps could be attached to the licence should the Sub-Committee decide to grant the application, in addition to any additional conditions the Sub-Committee believe appropriate for the promotion of the Licensing Objectives. Conditions have been agreed with the Metropolitan Police that would re-write what was offered by the Applicant and we believe could be converted to conditions.
- 5.6 Twenty-one relevant representations regarding this application were received, all from local residents.
- 5.7 For ease, conditions agreed with the Metropolitan Police are included as an annex to this report. The Sub-Committee may choose to form some conditions on the licence from these should they decide to grant the licence.
- There has been a previous application for a premises licence at this address that was refused by the Sub-Committee in August 2020, but our records show this was from a different applicant.
- It must be remembered that each application should be considered on its own merits.

## **Condition agreed with the Metropolitan Police**

1. A closed-circuit television (CCTV) system shall be installed at the premises. The CCTV system installed at the premises shall be maintained in effective working order and shall be in operation at all times the premises is open to the public. All recordings made by the CCTV system shall be retained and stored in a suitable and secure manner for a minimum of 31 days and shall be made available on request to the Metropolitan Police, the Licensing Authority or other Responsible Authorities. At all times the premises is open to the public a minimum of one member of staff on duty will be able to operate the CCTV system.
2. An incident log shall be kept at the premises and made available on request to Metropolitan Police, the Licensing Authority or other Responsible Authorities. It must be completed within 24 hours of the incident and will record the following; All crimes reported to the premises. All complaints received concerning crime and disorder. Any incidents of disorder. Such logs to be kept for a period of 6 months.
3. If a delivery staff member is carrying out their delivery they must wait to collect any orders inside the premises and shall not loiter outside the premises.
4. Clear legible notices are to be displayed at all exits from the premises requesting patrons to respect the needs of local residents and to leave the premises and area quietly.

### **a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)**

The licensing objectives have been considered taking into account the nature of the premises and the proposed style of operation.

The premises will operate in accordance with all relevant legislation.

The premises will liaise and co-cooperate with the Responsible Authorities.

The premises shall close to the public after 02:00 and will then operate solely as a delivery service until 05:00.

### **b) The prevention of crime and disorder**

A CCTV system with recording equipment must be installed and maintained at the premises.

All recordings used in conjunction with CCTV must:

- Be of evidential quality in all lighting conditions;
- Indicate the correct time and date; and
- Be retained for a period of 31 consecutive days.

An incident/accident book or electronic record must be kept to record all instances of disorder, damage to property and personal injury at the premises. Such records must be made available for inspection and copying by the Police and other officers of Responsible Authorities. Records are to be retained at the premises for at least 6 months.

### **c) Public safety**

The premises will operate in accordance with all relevant legislation which promotes the prevention of public safety objective. For example, the Health & Safety and Food Safety legislation

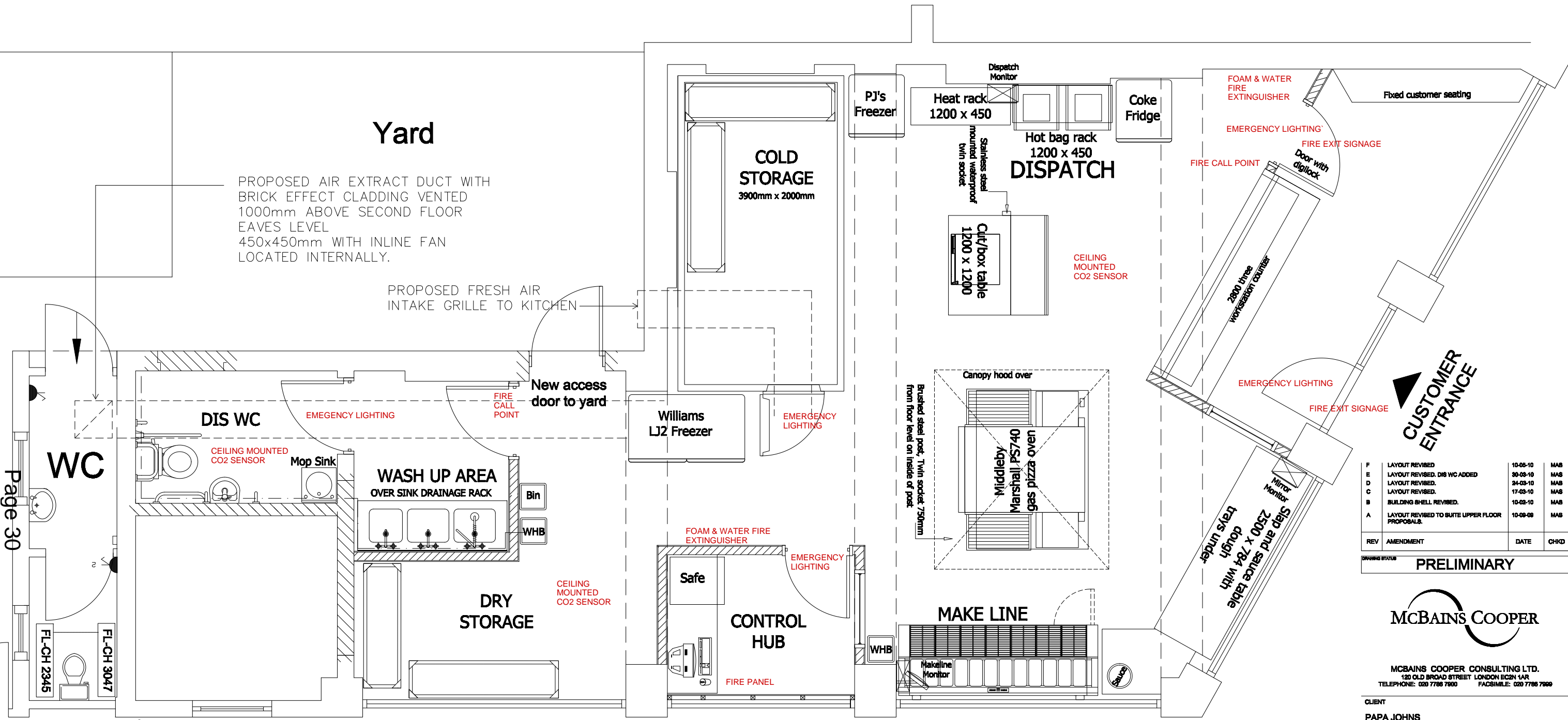

I would like to object to the current application put forward by Papa John's Pizza on 413 Durnsford Road for a new premise license.

I am a local resident and I am concerned that the proposed late opening hours would likely lead to public nuisance (Prevention of public nuisance) and potentially also to crime and disorder (Prevention of crime and disorder).

Specifically, I am concerned about a worsening in noise pollution, disturbances and antisocial behaviour. We already experience some noise disturbance and incidents of motorbikes revving their engines in the vicinity of the establishment. Furthermore, there is a problem with empty bottles being discarded onto the pavement at the top of Mount Road. Many of the local residents, myself included, have also observed that there is strong smell of cannabis emanating from the premises and immediate vicinity, frequently and at different times of the day.

As you can imagine, this is already a nuisance and a public safety concern as the premises are at the top of our residential road, and myself and many of my neighbours have young children. These issues are having a detrimental impact on our local community.

We anticipate that with extended opening hours these problems will be made worse and lead to disturbances into the small hours. I also worry that late opening would attract further antisocial and potentially criminal activity.

For these reasons I would strongly urge you to deny this application.

I am writing to share my concerns with above the licensing application made by PJ Corp Stores Limited for the 413 Durnsford Road branch of Papa Johns to remain open to the public until 02:00, and then for delivery until 05:00.

I am a local resident and I do not believe that the applicant meets any of the four licensing objectives, as outlined below:

### 1. Prevention of crime and disorder

The premises is located in a primarily residential location. By extending its opening hours, it will become a 'hub' for groups to congregate late at night, increasing noise disorder and crime. This will very likely bring with it the associated violence and drug use that similar late night venues suffer from. Myself and a number of other local residents have already observed the smell of cannabis emanating from its immediate vicinity and have witnessed confrontations between groups of males as they arrive and depart under the current licencing arrangement.

Moreover, foot traffic to and from the premises is through residential streets and undertaken by revellers who show little regard for the impact noisy conversations have on sleeping residents. This is already a challenge faced by local residents and one which will only be exacerbated by extending opening hours.

While the applicant has suggested the installation of CCTV cameras, this will do little to deter any of the above from taking place.

### 2. Public safety

The premises is located on a busy main road that does not have adequate parking for patrons or delivery drivers. As a result, vehicles collecting orders currently mount the pavement of the surrounding residential roads, particularly the adjoining Mount Road. During daylight hours, this causes a risk to public safety, particularly given the number of local residents with young children and push chairs.

It is much more dangerous at night as the area is relatively poorly lit, and hence extending the opening hours of the premises into the night increases this risk to public safety.

### 3. Prevention of public nuisance

In addition to the concerns raised regarding crime and disorder, the premises currently generates a significant amount of refuse. The disposal facilities are not fit for purpose and often result in rubbish strewn across the surrounding residential area following high winds or disturbance from foxes. Indeed, local residents have

taken to organising 'litter picks' in order to address some of the refuse created on our streets. Extending the opening hours will only increase the refuse generated and thus exacerbate challenges with its disposal.

Moreover, I am concerned that granting of a new licence for this premises may set a precedent for other food delivery venues in the local area, multiplying the public nuisance concerns of local residents from a crime, disorder and refuse perspective.

#### 4. Protection of children from harm

Many of the residents surrounding the premises have young children. The premises is also located within 200 meters of Wimbledon Park Primary School. I am a local resident and I am concerned that the proposed late opening hours would likely lead to public nuisance (Prevention of public nuisance) and potentially also to crime and disorder (Prevention of crime and disorder).

Specifically, I am concerned about a worsening in noise pollution, disturbances and antisocial behaviour. We already experience some noise disturbance and incidents of motorbikes revving their engines in the vicinity of the establishment. I would like to object to the application put forward by PJ Stores (Papa John's Pizza) on 413 Durnsford Road for a new premises licence.

I am a local resident living on Mount Road, the Papa John's premises are at the top corner of our residential road where many families with young children live. I am concerned that the proposed late opening hours would likely lead to public nuisance and potentially affect public safety.

Public nuisance

Operating the premises late at night is likely to cause public nuisance which will impact on the local residential area. We already experience a lot of noise pollution within the existing opening hours of Papa John's with motorbike engine revving going on late into the evenings. We also already see a detrimental impact on the neighbourhood with discarded rubbish around the premises. I cannot see how either of these public nuisances would improve with longer opening hours.

Public Safety

I am also concerned about public safety. The drivers who pick-up their deliveries already show little respect for road traffic laws. Riders regularly drive across parts of the pavement outside Papa Johns and pull out erratically onto ongoing traffic. Extending hours will not improve these conditions and may also contribute to an increase of accidents and injuries.

Community Engagement

Since Papa John's last attempt at extending their operating hours in 2020, they have made no discernible attempts to engage with the local community or take on board complaints of the local community. I do not imagine, they will do anything further in this regard if granted a later licence.

Lack of Justification

Finally, I do not understand the purpose of prolonging the hours of these premises and can see no real justification for it. They are not located on a busy high street or a commercial zone. This is a very residential area surrounded by a primary school and nurseries. The relevant premises form part of a small row of shops, none of which operate late licensing hours. The premises are not in immediate proximity to any stations and there is thus no obvious footfall that would benefit from access until 2am. The closest pubs on that road, serve food and do not operate extended opening hours. Should customers want to use their delivery services, multiple other Papa John premises already offer late services in the same area within a 10 minute

driving radius. There is, therefore, no discernible benefit to the public or Papa John's customers in being able to order late deliveries from that particular residential branch.

I am writing as a local resident to Papa Johns Pizza at 413 Durnsford Road in relation to their application for a new premises license for extended hours.

Papa Johns is already not a good neighbour to have and I am therefore concerned that the additional proposed late opening hours would likely lead to increased public nuisance (Prevention of public nuisance) and to an increase in crime and disorder (Prevention of crime and disorder) therefore unable to meet two of the Licensing Objectives.

Specifically, I am concerned about a worsening in noise pollution, disturbances and antisocial behaviour. We already experience some noise disturbance and incidents of motorbikes as the delivery platform bikes collect from the premises. Whilst I realise Papa John's does not employ these riders, the very presence and activity of Papa Johns attracts these riders. They regularly have no regard for pedestrians or other vehicles, particularly as they mount the pavement to get to the front door and pull out across the road in an erratic way.

The business does not manage its waste well and have only recently take responsibility for this, coinciding with this planning application! we frequently have to walk past their business waste strewn across the pavement.

The premises are at the end of our residential road that is busy during the day but very quiet at night. There is no other late night license in this area and this should not be used to set a precedent for other businesses to apply in this highly residential area. The vast majority of the businesses in this area close by 6pm, all other businesses close by 11pm including the Sainsbury's Local and other nearby takeaways. Approving this would set a dangerous precedent for our area which may result in a number of late night license applications dramatically changing the nature of the area. This late night license would not be used by the local community but would attract trade from people travelling specifically to this destination and delivery riders only. This is not a town centre, there are other nearby Papa John's in Wimbledon and Putney town centres that can fulfill this need.

At the last late night license application submission which was denied in 2020, Papa Johns was advised to engage with the local community, but we have not seen any such engagement which includes no participation in our street parties and no communication about this licensing application. To give some credit they did convert all their motorbikes to electric bikes but they have now removed all these and are only delivering through external food delivery platforms, meaning they are not in control of the behaviour of these riders.

We anticipate that with extended opening hours these problems will be exacerbated and lead to additional disturbances well into the middle of the night along with further waste issues, increased overnight deliveries whilst attracting further antisocial activity. This location is wrong for this type of license.

For these reasons I would strongly urge you to deny this application.

I am a local resident and I am concerned that the application would fail to meet all four licensing objectives – prevention of crime and disorder, public safety, prevention of public nuisance, protection of children from harm.

It is important to note here that as the primary school is so close, this area is almost exclusively full of families with young children (I have two myself). It is not a student area or an urban area where nocturnal activity is the norm and therefore it is profoundly anti-social to locate an all-night food vendor in the middle of it. (public nuisance) It should be noted that Papa John's has all night opening hours in nearby town centres of Wimbledon and Putney, these are urban areas where it makes more sense. There is no need to extend this to a local neighbourhood.

It was my belief that local government have been working hard to decrease traffic and its environmental impact in local neighbourhoods but this is one way to ensure it is significantly increased all night long. This will have an environmental impact but of course will cause anti-social noise throughout the night. On top of this, delivery drivers using Papa John's routinely drive their mopeds carelessly over the pavements which is a hazard to say the least, particularly with so many young children around. (public nuisance, protection of children, public safety)

There are already thefts in the area which are very hard to police and this is likely to increase with an increase in activity/footfall all through the night and therefore the risk of crime. It should also be noted that myself and other local residents have noticed a strong smell of cannabis coming from the premises and the vicinity which would no doubt increase if this becomes an all-night establishment. The residents of [redacted] would like to object to the application made by Papa John's Pizza on 413 Durnsford Road SW19 8EE (the Restaurant) for a new premises license which would extend their opening hours up to 5am (7 days a week) (the Application).

The Restaurant operates in a highly residential neighbourhood with several young children, including those who attend Wimbledon Park Primary School. As local residents we are deeply concerned that any extension to the hours of operation of the Restaurant would create a number of unwelcome issues for local residents, including in particular the following:

(A) public nuisance - as Merton Council would be well aware, excessive littering and vandalism inevitably affects the vicinity of any establishment serving fast food late at night. Discarded food packaging and boxes, discarded (and sometimes shattered) glass bottles, and unsanitary habits of inebriated patrons exhibited in streets and pavements near the Restaurant would be extremely unsafe, unpleasant and unhygienic for residents living in the neighbourhood and would overburden the Merton Council with the extra cost and effort to keep such streets and public areas clean and sanitary;

(B) crime and disorder issues - unsocial and inappropriate behaviour (including violence, theft, trespass and other criminal behaviour, consumption of drugs and the use of inappropriate and disrespectful language) is often exhibited by patrons in the vicinity of establishments open late at night, and particularly during late night hours. The occurrence of any such issues in the vicinity of the Restaurant at night would threaten the safety and security of residents, and create noise pollution and other disturbances of the peace. As residents of a quiet and peaceful neighbourhood and as parents of a young child, we are extremely opposed to the creation of any avenues (such as the extension of the Restaurant's operating hours) that could facilitate such behaviour; and

(C) public safety concerns - delivery drivers create numerous safety issues for pedestrians and vehicles including, the improper/erratic use of e-bikes on pavements, the absence or non-use of warning lights and indicators, and a general disregard for road rules. As the Restaurant operates in a highly residential area and a significant percentage of its revenue comes via the use of delivery drivers, the extension of its opening hours to 5am would greatly increase the risk of accidents occurring on the streets and pavements at night time.

While we strongly encourage Merton council to implement efforts to generally improve the quality of the high street on Durnsford Road, granting the Restaurant

permission to operate late at night is counterintuitive to such efforts and would, for the reasons noted above, be greatly detrimental to the neighbourhood within which the Restaurant operates. Accordingly, we strongly urge you to the Application.
