Chair's Forward

Scrutiny was introduced in Merton in June 2000, as part of the Government's modernising local government agenda. The role of scrutiny is to review decisions taken by the Executive and to develop policy by looking in-depth at particular areas of the Council's work. In Merton, we established pilot arrangements for a Scrutiny Commission and a number of ad-hoc and standing scrutiny panels. A revised Constitution was agreed in October 2001, leading to new structures for the overview and scrutiny process.

There have been many challenges in this second year of scrutiny in Merton. We have achieved a lot and will take note of the lessons for the future. Our structures have been praised by external inspectors, particularly for cross-party working and policy development. I hope that this report highlights our successes as well as areas for development. A particular challenge for the coming year will be to put in place arrangements for scrutiny of local health services. We look forward to working with new partners to develop processes that will contribute to the development of health services for the people of Merton.

Much of the scrutiny programme for 2001/02 was conducted under the Chairmanship of my colleague, Councillor Joe Abrams, who was Chair of Overview and Scrutiny until February 2002 and I would like to commend him for his enthusiasm and his contribution to establishing scrutiny in Merton.

Many individuals and organisations have made an invaluable contribution to the work of the Overview and Scrutiny Commission and Panels. We, and our overview and scrutiny colleagues, would like to thank all those who have attended meetings, provided evidence and otherwise supported the overview and scrutiny process. I look forward to working with you in the future to further enhance the policy and decision-making process of our Council.

Scrutiny in Merton 2001/2002

1. INTRODUCTION

This has been another busy year for what has now become *Overview and* Scrutiny. Following a seventeen month pilot of new political arrangements, the Council adopted its new constitution in October 2001. This resulted in some changes for the scrutiny function:

- A new role of scrutinising decisions not yet taken i.e key decisions in the Forward Plan
- Called-in decisions i.e those decisions already made to be considered by the Overview and Scrutiny Commission rather than by one of the scrutiny panels
- New criteria for call-in requests
- 4 Overview and Scrutiny Panels with a wider role than the previous Standing Scrutiny Panels

From May – October 2001 the scrutiny structure remained as established for 2000/01:

- A Scrutiny Commission as a cross-party committee of 17 members meeting monthly.
 Its remit included examining decisions of the Executive Committee, Reviewing
 service quality and performance, undertaking general policy reviews, developing the
 Best Value Performance Plan and determining the work programme for the scrutiny
 function
- 5 Standing Scrutiny Panels of six members each and established as formal subcommittees of the Scrutiny Commission to consider those decisions of the Executive Committee referred to them by the Scrutiny Commission. Each covered specific Portfolio areas as follows:
 - Panel 1: Finance and Corporate Support
 - Panel 2: Regeneration and Physical Environment
 - Panel 3: Care Services & Housing Management and Support
 - Panel 4: Primary Education and Children's Services & Secondary Education
 - Panel 5: Special Projects (Schools Reorganisation)

A number of ad hoc policy review panels were also set up, although policy review work was also done by the portfolio-related Standing Scrutiny Panels meeting informally as Policy Review Scrutiny Panels.

From October 2001, following the Council meeting on 18 October 2001, the structure of overview and scrutiny changed (see Appendix A for a structure chart). The main features were:

 A 5-week cycle of formal meetings including 2 Commission meetings and 1 of each Panel meetings. The cycle, and agreed protocols for decision-making, allow for all decisions to be published at the same time shortly after the Cabinet meeting, with one deadline for receipt of call-in requests

- An Overview and Scrutiny Commission made up of 20 Members, plus 4 co-opted members for Education matters.
- 4 Overview and Scrutiny Panels:
 - Finance and Corporate Support
 - Environment and Regeneration
 - Care Services and Housing Management
 - Education and Lifelong Learning
- Some ad hoc policy review panels remain for cross-cutting reviews. Most policy reviews, however, are now conducted by the relevant Overview and Scrutiny Panel during their scheduled meetings.

There are also 3 Best Value Panels which have operated under the same procedures as last year. Their role is to oversee the Best Value Reviews undertaken as part of the Council's five year programme. The outcomes of each Best Value Review together with the three year Improvement Plans are recommended to the Overview and Scrutiny Commission before being forwarded onto the Cabinet.

Membership of the Overview and Scrutiny Commission and Panels during 2001/02 is shown in Appendix B.

2. **SCRUTINY IN 2001/02**

Policy Reviews

Appendix C gives details of the policy reviews undertaken during the last year. 15 reviews were undertaken this year, some of which were started during the previous year, whilst others will be carried over to 2002/03 for completion. Six of these reviews were short reviews held during one meeting, but the need for many of the shorter reviews carried out in the first year has largely been superseded by the introduction of pre-decision scrutiny. This gives the Commission and Panels the opportunity to offer views on policy documents and other key decisions before a decision is made.

Key Scrutiny Review reports published this year have included:

- Consultative Forums
- Use of Consultants
- IDeA Action Plan

We have also been pleased to see that the Executive Committee accepted all the recommendations of the Scrutiny report on setting up Area Forums in Merton and that four Area Forums have now been established and are meeting guarterly.

A number of policy reviews have now been ongoing for some time, often tracking major projects as they progress. Recommendations have been made, and taken on board by officers and the Cabinet, on an ongoing basis. This has been valuable to those progressing the issues, and highlighted the importance of non-Executive Member involvement in those 'big issues' for the Council. The Commission will be considering how best to take this vital element of overview and scrutiny forward as an area of work in itself, as distinct from policy reviews. Guidance and good practice on conducting a policy review is also being prepared and will be issued in 2002/03.

Since October 2001, most policy review work has been done by the 4 Overview and Scrutiny Panels, during their scheduled meetings. Analysis of how the Panels have spent their time suggests that time for effective policy review work has been squeezed by pre-decision scrutiny and other items such as monitoring.

Pre-decision scrutiny

From November 2001 each Overview and Scrutiny Panel and, in some cases, the Commission itself, reviewed the monthly Forward Plan and identified those issues they wished to examine in detail before a decision was made. This pre-decision scrutiny only applies to 'key decisions' to be taken by the Cabinet, individual Cabinet Members or Chief Officers, but has enabled scrutiny Members to debate issues more fully and to contribute to the development of Council policies.

31 items were selected for pre-decision scrutiny up to April 2002. Further details of these are shown within the summaries of each Panel's work in Appendices E1-E4. Over 95% of the recommendations were accepted in full or in part. Panel Members have spent approximately 50% of their time at meetings on pre-decision scrutiny since it was introduced.

Called-in items

7 items were called-in this year, significantly less than reported in last year's annual report (38). In part this is due to the tightening of criteria for call-in since October. The introduction of pre-decision scrutiny also appears to have had an impact. However, there were only 6 items between May and October, which continued the trend appearing at the end of last year for using the call-in procedures more strategically.

A summary of the outcome of called-in items is shown below:

Scrutiny of 2002-03 budget proposals

Following the successful scrutiny of the 2001/02 budget proposals, a similar process was followed for scrutiny of the 2002/03 budget proposals in February. Four separate Panel meetings, a joint Panel meeting and then an Overview and Scrutiny Commission meeting were held. For the first time, 3-year budget proposals were considered (although the main focus was budget decisions for the coming year) and were linked to the Council's strategic objectives. Although the scrutiny process is intense and time-consuming, it produced, after thorough debate, recommendations to Cabinet and Council that were accepted in full.

Preparing for health scrutiny

The Scrutiny team has continued to develop links and relationships with the Merton and Sutton Community Health Council (MSCHC) and the London Borough of Sutton, with whom we are now 'sharing' the Sutton and Merton Primary Care Trust. Scrutiny team members attended regular joint liaison meetings with MSCHC and Sutton officers and have attended seminars on preparing for health scrutiny. The CHC gave a presentation on their work to the Overview and Scrutiny Commission in February, to which all Members were invited. Scrutiny Members met to agree the Council's response to the Government's consultation on Local Authority Health Scrutiny and we now await further Government guidance due later in 2002.

Developing scrutiny in Merton

We have continued to learn from what is happening elsewhere. Members of the Scrutiny team have attended public meetings of the Health Select Committee at the House of Commons, bringing back ideas which have been fed into our procedures and protocols. The Scrutiny Manager continues to be part of a London Scrutiny Network.

In October/November (following the changes to the Constitution) a briefing session was held for Chairs and Vice Chairs of the Commission and new Overview and Scrutiny Panels. An information/training pack was produced for use during this session. This pack was used as the basis for developing information for new Members after the May elections.

One of our aims for 2001/02 was to increase community engagement in the scrutiny process and some successful work has been achieved, for example:

Co-optees appointed by two panels

- Evidence given by individuals and representatives of community groups at policy review panel meetings
- Panel members holding meeting with local residents at venues outside the Civic Centre

We intend to build on this during 2002/03.

District Audit's Annual Management Letter 2000/2001, published in December, referred to the good work that had been done in scrutiny to develop Council policy in specific areas. It also said that the use of call-in had slowed Council business early in the pilot stage, although the changes in the Constitution have gone a long way to improve this. We were pleased to note that District Audit's report on 'Democratic Renewal', published in January 2002, observed that, although initial experience of scrutiny in Merton had been mixed, ".... there have been some excellent examples of policy formulation and complex issues have been tackled...".

The Scrutiny team

Once again we have been supported in our work by the Scrutiny team this year. Although recruitment to two vacant posts of Scrutiny Policy officer and Scrutiny and Policy Co-ordinator was finally achieved in October 2001, the secondment of the new Policy officer to the Corporate Governance team from November to March had an impact on the amount of research the team could undertake for us.

3. WORK UNDERTAKEN BY THE OVERVIEW and SCRUTINY COMMISSION AND PANELS

This section provides a brief summary of the work and achievements of the Overview and Scrutiny Commission and its Panels. The work programme of the Overview and Scrutiny Commission is shown at Appendix D, whilst more detailed summaries of the Panels' work are shown in Appendices E1 – E4.

Overview and Scrutiny Commission

The Overview and Scrutiny Commission (Scrutiny Commission until October) met 12 times during 2001/02.

The Commission considered a wide range of issues including call-in, pre-decision scrutiny, best value reviews, policy reviews, scrutiny work programmes, strategic plans listed within the Council's Policy Framework and many other corporate, strategic issues that have been brought to the Commission as the voice of non-Executive Members. Since October, the Commission has dealt with called-in items itself rather than referring items to the Panels (although only one item has been called-in since October).

The Commission occasionally undertakes pre-decision scrutiny itself and has done so on two occasions.

Finance and Corporate Support

The Panel completed a major policy review on the Council's 'Use of consultants' and its recommendations were accepted in full. The Panel has already commenced its monitoring role in relation to numbers of consultants employed and the nature of their contracts.

The Panel considered 15 pre-decision scrutiny items between October and April.

Environment and Regeneration

The Panel commenced a scrutiny review of the State of the Environment in June 2001. Work on this review will be carried over to 2002/03.

The Panel considered 6 pre-decision scrutiny items between October and April.

Care Services and Housing Management

Work has continued and almost completed on two major policy reviews:

- Implementation of the Day Care Review
- Housing Stock Transfer

The Panel has also contributed to the Joint Review of Social Services by offering comments to the lead inspector during their February meeting.

The Panel considered 3 pre-decision scrutiny items between October and April.

Education and Lifelong Learning

The Panel has continued their ongoing policy review on the Schools Reorganisation project, which has followed the implementation of this major scheme.

The Panel considered 5 pre-decision scrutiny items between October and April.

Ad hoc Policy Review Panels

DDA

This Panel began their review in April 2001. They are considering the implementation of the Disability Discrimination Act in Merton — what has been achieved and what still needs to be done? The Panel have worked to ensure that the views of local residents, staff and community groups are heard and to promote the Council's community leadership role in this area. The Panel hope to finalise their review and report their recommendations by the end of 2002.

Consultative Forums,

This Panel met to continue the work they had begun the previous year through their review of 'Area Forums in Merton'. The Panel met eight times from February to September 2001 to consider the implications of the introduction of Area Forums on the existing consultative forums. Their report and recommendations were presented to the Executive Committee in October 2001, with 16 of the 17 recommendations accepted.

IDeA

This Panel was established at the request of the Cabinet to develop and recommend the Council's action plan in response to the IDeA Peer Review report. This was an intensive piece of work over the Summer period in 2001. They have been monitoring the implementation of the agreed action plan; their continuation in this role will depend on the outcome of inspections in 2002.

Macpherson scrutiny panel

This Panel continued to meet to monitor and report upon progress in implementing the Stephen Lawrence Action Plan. They have reported their findings to the Cabinet.

4. HOW HAVE WE DONE? Impact of Overview and Scrutiny?

As our role develops and matures, it is important for the effective running of the overview and scrutiny function to consider the effect that we are having on Council policies and services. Our aims are to contribute to the policy and decision-making process so that more effective decisions are taken; and in doing this to provide decision-makers with useful, timely, relevant information and views. To do this, we need to ensure that we make the best use of the time available for overview and scrutiny.

As time goes on and the scrutiny role develops further, we aim to develop measures to enable an annual assessment of how well the scrutiny function is performing.

Some conclusions we have drawn from our work over the past year are:

- The number of 'called-in' decisions has dropped significantly, which may suggest that Members are content to use the opportunity of pre-decision scrutiny to comment on issues before decisions are taken and that decision-makers are taking wider views into account
- The number of short-term policy reviews has also fallen since the introduction of predecision scrutiny. This seems a more appropriate way for Members to comment on issues where a decision is to be made shortly
- Appendix C shows that most policy reviews last for at least a year (short reviews apart, which would now be dealt with under pre-decision scrutiny). Of the longer term policy reviews, only 2 have been completed this year (Use of Consultants and Consultative Forums). The nature of some reviews, which shadow and monitor ongoing projects, has been commented on elsewhere in this report, and the Overview and Scrutiny Commission will be considering the future of this area of work
- The current length of some policy reviews is probably too long. To be effective, a
 policy review should report within a timescale to impact on policy development and
 decision-making. The forthcoming good practice guide on policy reviews is likely to
 recommend a time period of 6 to 12 months, with a definitive cut-off point

- The impact of Constitutional change was underestimated. Interpreting the Constitution and managing the changing processes has often been confusing and time-consuming for officers and Members
- Continuing Member and officer concerns at the number of meetings held, whilst acknowledging that there is still a backlog of business to get through

Achievements and successes – what went well

Notable achievements this year have been:

- Scrutiny of the budget process which was intense but thorough, and produced workable, realistic recommendations
- Two major Policy Review reports on 'Consultative Forums' and 'The Use of Consultants' have been produced with recommendations accepted by the Cabinet
- All completed policy review reports have now been produced in a 'house style' and copies sent to those involved
- The first overview and scrutiny protocol on liaison with Cabinet Members has been agreed and issued
- Revised procedures have been drawn up following adoption of new Constitution, including procedures for pre-decision scrutiny and call-in
- Chairs and Vice-chairs meeting held in November 2001 to agree a common approach to implementing the revised procedures

Lessons learnt & areas for development

Areas for development that we have noted are:

- Some strands of scrutiny's publicity strategy are still to be put into place, eg updating of the Council's website and putting policy review reports onto the website
- Policy review work has suffered since October in terms of the amount of time that the panels can dedicate to this, and the Commission will be considering ways of addressing this
- Policy research and development support for reviews has also suffered due to staff shortages and this is likely to continue in the short term
- Terms of reference for policy reviews have not always been clear and some reviews have tended to focus on ongoing operational issues rather than policy and strategy development
- The call-in procedures introduced in October 2001 are complex and have lead to some confusion amongst Members. These procedures should be reviewed when the constitution is next reviewed in Autumn 2002.

5. THE WAY AHEAD – CHALLENGES FOR 2002/03

Overview and scrutiny continues to develop and change. With a further review of the constitution planned for the Autumn, and the new power of local NHS scrutiny coming into force from January 2003, the coming year promises to be as busy as the last. Below are details of some of the areas where we will be concentrating our efforts.

All change – post May 2002

The elections in May returned many new Councillors, many of whom have been appointed by the Council to serve on Overview and Scrutiny bodies. The challenge for 2002/03 will be to ensure that new overview and scrutiny Members receive the information and briefing materials they need to quickly understand their role and responsibilities.

We may need to review our processes and procedures again in the Autumn to take into account any changes to the Constitution agreed by Council.

Health Scrutiny

A new power of overview and scrutiny of local health services comes into force on 1 January 2003. This is likely to be our biggest challenge this year. Health scrutiny in this way is completely new to Local Authorities and the NHS and this is the first time we could be scrutinising the actions of another body. We will also be undertaking this new area of work without, at least initially, additional resources. Feedback from others and good practice seems to suggest that the most useful areas to scrutinise are:

- Service areas where the NHS and the Local Authority have a shared interest in and/or responsibility for a service/group of services, eg drug use/rehabilitation
- health promotion issues
- where a Local Authority decision impacts on an NHS service, or vice versa, eg transport to a local hospital

Resources permitting, we will be looking to run a short pilot health scrutiny review in the Autumn. By then, we should have further guidance and be in a better position to plan a future health scrutiny programme.

Publicity and involving the public

Although there have been some excellent examples of wider public involvement in policy reviews in 2001/02, this is an area for further development in the coming year.

An 'Introduction to decision making and scrutiny' leaflet will be produced as well as other information and materials, which together will form an information pack to be tailored as required. This, together with an expanded section on the Council's website, will ensure that information on the scrutiny process is more readily available.

To help ensure that people can become actively involved in the scrutiny process, guidance and protocols for involving external witnesses and co-optees are being developed. These, together with the policy review guidance, will be a framework for involving individuals and community groups in our work.


In addition, the Overview and Scrutiny Commission has agreed a new cross-cutting policy review on consultation with the public across the Council. The experience of looking in-depth at this area will help with our own strategy for involving the public in scrutiny.

Monitoring role

All four Overview and Scrutiny Panels began to consider their role in monitoring the overall performance of the Council earlier this year. Further work will be done on this, in particular identifying 'baskets' of performance indicators that each Panel will monitor on a regular basis. This will complement the monitoring undertaken by Cabinet and the Corporate management team as part of the Council's new Performance Management Framework.

Further work on a tracking system/database will be progressed. Initial discussions have already taken place, but this has not been progressed as quickly as we would have hoped. The aim is to have a system that will enable quick access to the progress of particular decisions and to monitor the impact of scrutiny recommendations.

We have a lot to look forward to in 2002/03, our third year of overview and scrutiny. Things won't stand still any more than they have in the past 2 years, but we aim to make the most of the challenges ahead to further improve the overview and scrutiny role at Merton, and make our contribution to Council policy and decision-making.
