The Committee agreed to ask Officers to consider relaunching the Curry Master Chief competition across the Joint Service area and to investigate sponsorship for the competition.

Members agreed that The Committee should lobby MPs to make the display of Food Hygiene Rating Scores mandatory on the frontage of all restaurants and fast food outlets.
